I recognize that as part of this activity other participants and I will be using airsoft guns that shoot pellets and I will traverse difficult and dangerous terrain and obstacles, and transport and use various simulated firearms and other simulated weapons, and I freely and voluntarily assume any and all risk of injury such activity involves. The attendees of this event have full knowledge of Military Simulation events on dangerous, often abandoned property and these properties do not meet normal safety requirements. I enter these dangerous properties of my own free will and understand that I could be putting my health and safety into peril and attendees will be using Airsoft guns and other simulated weapons and **understand that it may cause bodily harm, serious injuries, loss of limbs and death.** Attendees are required to wear proper full seal eye protection, face, ear and mouth protection and advised to wear helmets gloves, as well as other clothing and equipment that can protect them from airsoft BB's or the terrain used for the event. Barrel bags are required in non-playingareas.

#### For these reasons, I hereby waive and release from liability and agree to hold harmless the following:

1. Property owner: ARENA TRAINING FACILITY, 200 Sherman Rd, Blakely, GA 39823, its employees, officers, directors, shareholders, Members, Managers, and all of their affiliates.

2. Event organizers: CENTURION MILSIM, LLC and Arena Training Facility LLC and all other agents, employees and volunteers that help run the event and/ or participate in this event.

3. Event organizers: Centurion MILSIM, LLC and all other agents, employees and volunteers that help run the event and/or participate in this event.

I hereby grant permission for Emergency Medical personnel to treat me in the event that I am unconscious and/or unable to communicate freely. I understand that I will be treated under "Good Samaritan" standards, if a Medical Professional is not immediately available. As soon as possible I will be turned over to Medical or Ambulance personnel and transported to the nearest Hospital or medical facility.

Honor: Airsoft is a game of HONOR, all attendees are expected to call their hits and follow all rules and guidelines set up by event organizers. Failure to call your hits, failure to follow guidelines and rules can result in removal from the event without refund. I understand that OSCAR MIKE is privately held event. Event organizers reserve the right to deny participation to anyone. Attendees assumes responsibility and agrees to indemnify and defend CENTURION MILSIM LLC, Arena Training Facility LLC staff, event sponsors, event VIP, fellow attendees, event venue management and ownership, and their respective employees and agents against any claims or expenses arising out of the use of the property and general premises. While security personnel may be available generally for the purpose of safeguarding the general public, the attendees are solely responsible for the safekeeping of his/her own property while at the event.

All attendees are expected to and shall conduct themselves in a professional and courteous manner. Any attendee who, in the opinion of CENTURION MILSIM, LLC, Arena Training Facility LLC and Staff fails to conduct themselves in such a manner may be asked to leave the event at any time without any right to a refund of fees, either in whole or in part. Damage to property or use of non-BIO BB's will result in immediate removal from event. Based on damages, repair and/ or clean up fees players can be held criminally and/or civilly liable. Participant who violates the rules agrees to pay all legal fees associated with collection to repair or re-pay property owner and event organizers for losses they incur.

Possession of Alcoholic beverages or illegal drugs shall also result in immediate expulsion. In order to uphold these provisions, the attendees agree to permit reasonable inspection of their wares by a duly authorized CENTURION MILSIM, LLC, and/or Arena Training Facility LLC staff member or its agents.

Attendees must recognize that this is a Military Simulation (MILSIM) event, and that they will be assigned to a unit (Company, a Platoon and/or a Squad). Attendees must accept the command structure setup by event organizers. You must be willing to assist and guide those who may be assigned to your squad. Because you are being assigned to a unit you are expected to work through your chain of command, this includes notifying your chain of command if you are going to be absent or leaving the event early.

## Range Rules & Assumption of Risk and Release of Liability and Claims

### **Range Rules**

The following are strictly prohibited on Arena Training Facility Property (ATF):

- 1. No shooting at wildlife
- 2. No shooting cross-range
- 3. Shooters may not consume alcoholic beverages or drugs (including prescription and over-the-counter medications) that will affect his or her ability to participate with a maximum state of awareness and in a completely safe manner, before or during live fire operations. The Range Safety Officer (RSO) or any ATF employee will deny range access to anyone that is or appears to be in violation.
- 4. Ensure you read and obey all rules for each specific range you are on and ensure you are within the proper caliber for that specific range
- 5. FIRING OF ARMOR-PIERCING ROUNDS OR TRACER AMMUNITION IS PROHIBETED. Armor piercing ammunition means a projectile or projectile core which may be used in a firearm and which is constructed entirely, excluding the presence of traces of other substances, of tungsten alloys, steel, iron, brass, bronze, beryllium copper, or a combination of tungsten alloys, steel, iron, brass bronze, or beryllium copper.
- 6. 50 BMG CALIBER FIREARMS ARE PROHIBITED
- 7. No bullet impacts off the range, into signs, storage containers, signs, sheds, or any other structure or range feature not a ATF Cadre approved impact area.
- 8. No repeated misses of the target, or bullet strikes that ricochet causing a danger of bullets leaving the range
- 9. No disruptive activities, such as loud music or children that are not supervised properly on the firing line.
- 10. No loaded firearms are allowed on the ATF property other than on the firing line under a HOT RANGE CONDITION
  - a. Exceptions to this are ATF employees and customers properly licensed Georgia Carry Licensed individuals, and Law Enforcement personnel
- 11. Hands off all weapons while personnel are downrange
- 12. Keep weapons pointed in a safe direction always
- 13. Fire from designated firing platforms only
- 14. IMMEDIATELY call CEASE FIRE if you are unsure or witness something that is unsafe
- 15. Hearing and Eye protection is required while range is active
- 16. CLEAR and SAFE all weapons prior to leaving firing line

### Range Rules & Assumption of Risk, Indemnity, and Release of Liability and Claims

I, the undersigned, represent that I am over the age of eighteen (18) years old. I, and on behalf of my heirs, agents, assigns, beneficiaries, executors and administrators, do certify that I am aware of the hazards, inherent dangers and risks associated with the use of a gun range and understand that loaded firearms are discharged not only by me but also by other members, guests and visiting public. I agree to comply with the rules, regulations and safety procedures governing the use of Arena Training Facility and I assume any and all risks associated with the use of the facilities and the use and discharge of firearms, whether intentional or accidental.

In consideration for allowing me access to and use of Arena Training Facilities, I personally assume all risk in connection with said access and use, whether foreseen or unforeseen, and further for myself, my family, my guest, legal heirs, agents, assigns, beneficiaries, executors and administrators, do hereby release, save and hold harmless ATF Range Officers, directors, agents, and employees from claim, demand or liability (whether claimed by myself or another person or entity) which may arise out of any loss, damage, injury or death to myself as well as any theft, unexplained disappearance or damage which may befall any personal property I brought to the facility, which may arise while I am at the facility and/or engaged in the use of the, services, or equipment of Arena Training Facility. I VOLUNTARILY ASSUME ALL SUCH RISKS FOR MY FAMILY MEMBERS, INCLUDING MINORS, GUESTS AND MYSELF (and heirs, agents, assigns, beneficiaries, executors and administrators).

I, and on behalf of my heirs, agents, assigns, beneficiaries, executors and administrators, agree to indemnify, defend, and hold harmless Arena Training Facilities, its Officers, directors, agents, members and employees, from and against any and all damages, loss, liability and other claim caused by my use of the Arena Training Facilities, services or equipment, and the discharge of firearms which would include, but not be limited to, damages or personal injuries caused by my negligence and/or the negligence of others that I have brought to the ATF, such indemnification to include all court cost, attorney's fees, expenses, and liabilities incurred in and about such claims, investigations thereof any action or proceeding brought thereon and from against any orders, judgements and/or decrees which may be entered therein.

It is understood that I am personally responsible for the safe handling and proper functioning of any firearm or munitions that - I use while at the Arena Training Facilities. ATF has no responsibility to guarantee, verify, or approve the safety and functioning of any firearms or munitions that I may bring onto the facility.

I further state that I am of lawful age and legally competent to enter into this affirmation and release, and I understand the terms herein are contractual and not mere recital, and I have signed this document voluntarily and as my own free agent. I understand that ATF Officers may immediately terminate my participation in activities upon any failure of mine (or my guests) to fully cooperate with the ATF Rules and Regulations and/or instructions of the ATF Officers.

I further certify that I am not under the influence of alcohol or drugs and that I am under no legal injunction that prohibits my owning, possessing, handling or using any firearms.
